- I understand that neither the Rockdale Family Law Information Center, nor the consulting attorney guarantees or warrants the results of the legal advice provided.
- I understand that the Office of the Clerk of Superior and State Courts provides only scheduling support and general information and is prohibited by law from offering legal advice, opinion or referrals.
- **I understand that missed appointments without 24 hours notice WILL NOT BE RESCHEDULED.**
