**STANDING ORDER REGARDING PAYMENT OF ORDERED RESTITUTION,
FINES AND FEES AND PROBATION SUPERVISION FEES**

When a Defendant is sentenced to probation in either a felony or misdemeanor case in the Superior Court of Rockdale County and part of the Defendant's sentence includes a period of probation, the following shall apply:

IT IS HEREBY ORDERED that restitution and fines and fees that are ordered to be paid by the Defendant as part of his/her sentence shall be paid in the Office of the Clerk of the Superior Court. All monies paid shall be applied first to restitution and once all restitution has been paid, thereafter to fines and fees. During the period that the Defendant's payments are being applied solely to restitution, as long as such payments are being made in a timely fashion, the fact that fines and fees are outstanding shall not be a ground for the revocation of probation.

IT IS FURTHER ORDERED that the Rockdale County Department of Community Supervision shall furnish a statement to the Clerk of the Superior Court for each individual currently on probation and who were sentenced to pay restitution and/or fines and fees showing all previous payment activity prior to March 1, 2021, and how such payments have been allocated.

IT IS FURTHER ORDERED that if the Rockdale County Department of Community Supervision is holding any monies collected for restitution and/or fines and fees that have not be distributed such monies shall be disbursed to the Clerk of the Superior Court with sufficient information for the Clerk of Superior Court to apply such monies to the correct probationer's financials.


IT IS FURTHER ORDERED that the Rockdale County Department of Community Service shall, for each probationer ordered to pay restitution, provide to the Clerk of Superior Court the name and current address of the recipient of any restitution due.

IT IS FURTHER ORDERED that probation supervision fees shall continue to be paid to the Department of Community Supervision in a manner as directed by such Department.

IT IS FURTHER ORDERED that no probationer shall be placed on unsupervised probation unless all of such individual's restitution, fines and fees are paid in full and the Department of Community Supervision fees are current.

IT IS FURTHER ORDERED this Standing Order shall be effective March 1, 2021 and continuing thereafter until further Order of the Court.
